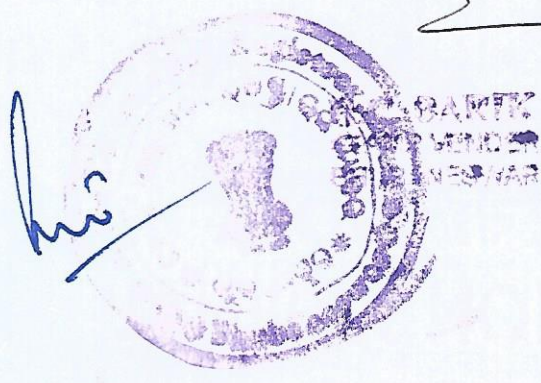

2) That the name of the trust shall be **SAINT XAVIER EDUCATIONAL & CHARITABLE TRUST**, and its office shall for the present, be situated at 12, Janpath, Satyanagar, P.O. : Satyanagar, P.S. : Kharavel Nagar, Bhubaneswar, Dist.- Khurda, Orissa and /or at such other place or places as the trustees may decide from time to time.

3) That, the objects for which this trust is established are :-

- ❖ To undertake schemes for rehabilitation of senior citizens and orphanage children of Orissa State.
- ❖ To establish, develop, maintain and grant aid in cash or kind to Odissi Dance Schools and/or such other similar charitable institutions in India for the benefit of general public.
- ❖ To establish, run, support and grant aid or other financial assistance to schools, colleges, libraries, reading rooms, universities, laboratories, research and other institutions of the like nature in India for use of students and the staff and also for the development and advancement of education and diffusion of knowledge among the general public.

To accept any donation, contribution, grant or subscription in cash or in kind, from any persons(s) body of persons or trust, with or without conditions and to acquire by gifts, purchase, transfer, exchange, mortgage, lease, hire or otherwise of any lands, buildings, lease of any property or sell any property for the furtherance of all or any of its objectives as decided by the Trustees.
- b. To apply the whole or any part or the income of the trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
- c. To convert and deal with the Trust property and / or any investments for the time being.
- d. To invest the Trust Fund either in the purpose of mortgage of immovable property or in shares, stock or debentures or other securities and investments, or in deposits with or loans to any company, bank, firm or any other person, and to alter, vary or transpose such investments, from time to time at the discretion of the trustees.
- e. To sell, dispose of alienate or otherwise deal with any property comprising the Trust Fund.
- f. To let out, demise any immovable property comprised in the Trust Fund for such period and at such rent on such terms and conditions as the Trustees in their discretion as the Trustees in their discretion may think fit.
- g. To open account in the name of the Trust, Trustees and/or Institution run/ conducted by the Trust with a Bank or Banks, to operate such account and to give instructions

h. To adjust, settle, compromise, compound refers to arbitration all actions, suits, claims demands and proceedings regarding the Trust Fund.

i. To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organizations or Trusts in India which may hereinafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institution societies, organization or Trustees to start, maintain, or carry out such charitable objects.

j. To appoint constituted attorneys or agents and to delegate to such attorneys or agents all or any of the powers vested on them under these presents and from time to time remove such attorneys or agents and to appoint other or others in his or their place.

k. m. To start, abolish, discontinue and restart any charity or charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.

n. To settle all accounts and to compromise, compound, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any property comprised in the Trust.

o. To take over or amalgamate with any other charitable Trust, Trust, association or institution with similar objects.

p. To apply to Government, public bodies, urban local, municipal, district and other bodies, corporation, companies or persons for and to accept grant or money and of aid, donations, gifts, subscriptions, and other assistance with a view to promoting the objects of the Trust and to discuss and negotiable with the Government Departments, public other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.

q. To transfer all or any part of the property, assets, liabilities and engagements of this Trust to any one or more of the Trust, societies, institutions or associations with which this Trust is authorized to amalgamate.

r. To transfer and hand over the Trust to any other Trust, corporation, institution, Trust or organization ion such terms and conditions as the Trustees shall in their absolute discretion think fit and proper to be held by the Trust Corporation, institution, Trust or Organization with

the powers provisions and directions, appearing and contained in these presents subject to such modifications as may be necessary and consequent to such transfer of the Trust fund. The Trustees for the time being of these presents shall become disposed from the Trustee thereof relating to Trust funds so transferred.

- 8) That, the Trustees shall be accountable only for such moneys, stocks, shares and funds as shall actually come into their hands and a Trustee shall not be answerable or accountable for neglect, default, acts or omission or commission of the other Trustees, nor of any banker or other person with whom the trust properties or any securities may have deposited or kept.
- 9) That, the Trustees will not be entitled to receive any remuneration, but the Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.
- 10) That, the number of the Trustees shall not be less than four and more than ten. If the number of the Trustees shall fall below two the Trustees shall not, except for the purposes filling any vacancy, act, so long number is below the said minimum.
- 11) That, the Managing Trustees for the time being will be at liberty to appoint additional trustee within the number mentioned above for such period or on such terms as to retirement and reappointment as the trustees for the time being consider proper. (i) A person shall cease to be Trustee or for one calendar year, whichever is longer, or (ii) if he is requested to resign by  $\frac{3}{4}$ th or as near thereto as possible of the remaining Trustees.
- 12) That, every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.

13) That, the Trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations :

- a. Four Trustees shall form a quorum for meeting of the Trustees.
- b. Any controversial matter (s) will be decided mutually by the Trustees.
- c. Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.

14) That, the Trustees shall have the power to determine in case of doubt whether any moneys or property shall for the purpose of the charity be considered as capital or income and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authority the Trustees to spend the income or corpus of the Trust for any purpose not authorised by these presents.

15) That, the accounting year of the Trust shall be the financial year ending on 31<sup>st</sup> March, every year.

16) That, the Trust and the Trust funds shall be and irrevocable for all times.

17) That, the office of the Trust shall be situated in Orissa unless changed by the Trustees by two third majorities.

**THE GENERAL BODY :**

- (a) The General Body shall be the supreme advisory body of the Trust.

- (b) The General Body of the Trust shall be consultative and advisory in terms of their and authority.
- (c) The General Body will have a total of seven members.
- (d) The honorary (outside) members of the General Body shall be proposed and settled by the other members of the General Body by consensus.

**BOARD OF TRUSTEES :**

- (a) The board of Trustees shall have the supreme executive control and the management of the business and affairs of the Trust and the administrative powers of all the properties movable and immovable and shall have such powers of the Trust and do all such things to carryout the objectives of the Trust as one by the act, not required to be exercised or done by the Trust in General Body meeting.
